Terms & Conditions

The contract is for a short-term holiday rental of the FHLTA mobile home. The contract entered into is between the FHLTA and the holidaymaker (the hirer).

Bookings are accepted on the understanding that the property is taken for holiday purposes only and that the maximum occupancy of the mobile home is not exceeded.

The client and any friends or family of the client visiting the property while the client is staying there must adhere to the rules and procedures set out in the guidance folder provided in the mobile home.

Period of Hire

Rentals for the mobile home will commence at 3pm on the day of arrival and terminate at 10am on the day of departure.

The arrival time should be arranged in advance. The client should arrange an estimated time of arrival with the FHLTA representative Adele Lambert and inform them of any changes to ensure the FHLTA representative is available to meet and greet the client to hand over the keys and relevant site passes as well as to familiarise the client with the mobile home and its equipment.

Payment

Once the booking is confirmed by the FHLTA you will be required to complete the booking form and return to Adele Lambert via email Enquiriesfhlta@mail.com or post to Adele Lambert, 8 Harebell Meadows, Newton Aycliffe, Co Durham, DL5 4UG

Payments including a refundable deposit (see security/breakages) must be paid for by cheque or bank transfer to the FHLTA no later than two weeks before your arrival. Failure to comply may result in your booking being cancelled.

Security/Breakages Deposit

A security/ breakages deposit of £50.00 is required to be held at the time of the final payment. The deposit will be refunded providing there are no breakages, and the mobile home is left in a clean and tidy condition upon your departure.

Cancellation

The hirer is advised to arrange holiday insurance to give protection in the event that the hirer is unable, for any reason to take up the holiday accommodation at the agreed time. The hirer should inform the FHLTA of any cancellation immediately. In the event of a cancellation and the FHLTA being unable to re-let the mobile home the hirer will have £50.00 deducted from the full amount of holiday rental.

Bed linen

Bed linen is provided in the mobile home.

Towels

Please note we DO NOT provide towels; you will be required to bring your own with you.

Pets

Pets are allowed for a £10 fee for extra cleaning charge.

Rules and Procedures

Clients are required to observe the rules and familiarise themselves with the procedures contained in the guidance folder (Blue) provided in the mobile home.

Smoking is not permitted in the mobile home at any time, this also applies to visitors to the mobile home.
